 I began my legal career in public service as a Broward County Assistant State Attorney. I served as a prosecutor for three years, working my way up to become a lead in the Felony Trial Unit. I handled heavy caseloads in excess of 300 at a time, which prepares me for the demanding workload of a Broward County Circuit Court Judge. Working as a prosecutor afforded me unique insight into the workings of the criminal justice system, the courtroom and invaluable trial experience. I was recognized for excellence in my courtroom skills, when the Chief of the trial unit handpicked me to attend specialized training at the Institute of Police Technology and Management. After my tenure as a prosecutor, I went into private civil practice before opening my own law firm. Over the past 16 years I have been an avid litigator and negotiator in both criminal and civil law cases. I became a Florida Supreme Court Certified Family mediator in 2012. I have been appointed by judges in family court to serve as a Guardian Ad Litem (GAL), to advocate for children in divorce proceedings. As a GAL, it is a privilege to advise the judiciary on what is in the best interest of the child in the divorce. Additionally, it is an honor to be appointed as a GAL, because it signifies the judges recognize and respect my reputation for integrity, patience, compassion and professionalism.

- 12. Briefly describe any personal experiences you have had with GLBT friends or relatives.
 - I am an out lesbian and I have been involved in the LGBT community in different capacities for many years. I have served in many leadership positions in LGBT organizations. I was a founding incorporator of the Gay and Lesbian Lawyers Network ("GLLN") in 2011, and served as President from 2011-2015. The GLLN grew from 3 people at my first meeting to nearly 200 members including lawyers, judges, law students and local businesses. I am very proud of the profound impact the GLLN has had on the community by providing a platform for networking, education, mentoring, fundraising and socializing. In 2011, I was asked to join the board at the Pride Center at Equality Park. to help increase women's involvement at the Center. While on the Pride Center board, I volunteered to be the founding chair of the program "Women with Pride". "Women with Pride" began as an initiative to create a directory of healthcare providers sensitive to the needs of lesbian, bi-sexual and transgender (LBT) women. The program has since expanded to include education, networking, support groups and a full-time female staff. I am honored to have worked with so many incredibly dynamic women and men to get this program started and to watch how it has grown to meet the changing needs of the LBT community. I was one of Our Fund's First 100 Funders and a Liberty Circle Member with Lambda Legal. Professionally, I have represented and counseled many LGBT clients over the years. - 13. Briefly describe what you perceive as the greatest obstacles to justice.

 I believe the greatest obstacle to justice is access to the court system. Our system can be difficult to understand and typically requires legal counsel to effectively advocate a position. Many people do not seek redress for a legal issue because they are unaware they may have legal recourse or perhaps cannot afford an attorney.
- 14. Briefly describe what you hope to accomplish as a judge.

 Nearly every day for the past 16 years, I have gone to court seeking justice. As a judge, I will ensure justice is achieved and that all people are treated fairly. I will be an efficient judge, which begins with starting court promptly and being prepared for the docket of cases every day. I will apply the laws evenly so parties can expect consistency in how I will handle matters. A judge's role is similar to being an umpire in a baseball game. Like an umpire, the judge makes sure both parties follow the same rules and that the rules are uniformly applied so the final outcome is fair. The judge, like the umpire, does not make the rules nor change the rules to favor one party over another.
- 15. Briefly describe the greatest strengths you bring to the judicial role.

 The greatest strengths I bring to the judicial role are a depth of experience, an even temperament, innate leadership skills and a strong work ethic. Organization, punctuality, and hard work are the characteristics that made me a successful Assistant State Attorney handling upwards of three hundred cases at a time and running a successful law practice as a solo practitioner. As a prosecutor I was often the first person to turn the lights on at the office, and I was often the last person to leave at night. My strong work ethic carried over into my private practice. I am the most qualified candidate because I have a depth of experience with over 50 trials, over 1000 evidentiary hearings, and I have handled a wide range of cases for plaintiffs and defendants in both criminal and civil law. Secondly, my temperament sets me apart as evidenced by the overwhelming support I have received from the community with endorsements from over 200 people and organizations, and contributions from over 600 people. My endorsements include the Victory Institute, the PBA (Police Benevolent Association), the IAFF (International Association of Firefighters), Democracy for America, elected officials, community leaders, and Broward County voters.
